The first **SCO International Investment and Trade Expo and SCO Local Economic and Trade Cooperation Qingdao Forum (SCO Expo and Forum)** was successfully held in Qingdao last year, which announced the prelude of the China-SCO Local Economic and Trade Cooperation Demonstration Area in Qingdao. Exhibition Scope: Energy, finance, logistics, infrastructure, manufacturing, medical care, education, tourism, light industry and other fields related to China's trade and investment with the SCO countries.

- **International Pavilions:** officially organized by each embassy, national chamber or famous enterprises of SCO countries to display featured products, culture and tourism and other fields of cooperation with China.
- **Chinese well-known enterprises:** Products and services including infrastructure, energy, marine, ports, logistics, artificial intelligence, machinery and electronics.
- **SMEs:** Products or services showed by small and medium enterprises from SCO countries (including China), such as consumer products, food, beverages, etc.
- **Online Exploration Area:** For those SCO companies which can't participate personally due to the COVID-19 pandemic, their products or services can be displayed in this area to interact with local and remote buyers.

 - ☐ Covering for part of the domestic exhibits transportation fee;
