The Republic of Tajikistan has applied for financing from the Asian Development Bank (ADB) toward the cost of **Additional Financing for Dushanbe Water Supply and Sanitation Project**, and it intends to apply part of the proceeds of this financing to payments under the contracts named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **State Unitary Enterprise (SUE) Dushanbevodokanal (DVK)** ("the Employer") invites sealed bids from eligible Bidders for the construction and completion of the following contract packages ("the Works"):

3. Bidders may bid for one (1) lot, combination, or both lots, as further defined in the Bidding Document. Bidders wishing to offer discounts in case they are awarded more than one (1) contract will be allowed to do so provided those discounts are included in the bid submission.

4. **Open Competitive Bidding (International Advertisement)** will be conducted in accordance with ADB's Single-Stage: One-Envelope bidding procedure and is open to all Bidders as described in the Bidding Document.

5. Only eligible Bidders with the following **key qualifications** may participate in this bidding:

Key Qualifications	Requirements
Historical Financial Performance	Submission of audited financial statements or, if not required by the law of the Bidder's country, other financial statements acceptable to the Employer, for the last 5 (five) years (i.e. 2017, 2018, 2019, 2020, 2021) to demonstrate the current soundness of the Bidder's financial position. As a minimum, the Bidder's net worth for the last year calculated as the difference between total assets and total liabilities should be positive.
Average Annual Construction Turnover	Minimum average annual construction turnover of US\$ 5.6 million for Lot 1 and US\$ 7.0 million for Lot 2 calculated as total certified payments received for contracts in progress or completed within the last five (5) years.
Financial Resources	<p>The Bidder must demonstrate that its financial resources defined in FIN - 3, less its financial obligations for its current contract commitments defined in FIN - 4, meet or exceed the total requirement for the subject Contracts:</p> <p>Lot 1 = US\$ 675,000.00 Lot 2 = US\$ 850,000.00</p> <p>Details are provided in the Section 3 of Bidding Documents.</p>
Contracts of Similar Size and Nature	<p>Participation as a contractor, Joint Venture partner, or Subcontractor, in at least one contract that has been successfully or substantially completed within the last 5 years and that is similar to the proposed works, where the value of the Bidder's participation exceeds amounts mentioned below. The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Section 6 (Employer's Requirements).</p> <p>for Lot 1: US\$ 3.6 Million for Lot 2: US\$ 4.5 Million</p>
