

**The Customs supports the Fifth CIIE  
(China International Import Expo) 2022**

**Facilitation Measures**

**1. Release customs clearance instructions and provide detailed customs clearance guidelines**

Formulated and issued the Customs Clearance Instructions of the Fifth China International Import Expo 2022, the List of Inspection and Quarantine Restrictions of the Fifth China International Import Expo 2022, and the Inspection and Quarantine Prohibition List of the Fifth China International Import Expo 2022 to provide detailed guidance for overseas exhibitors.

**2. Set up a regular organization to respond to demand at any time**

Shanghai Customs under the jurisdiction of Shanghai Convention and Exhibition Center Customs, will act as a regular organization of customs service for CIIE, in order to do a good job in customs supervision and service guarantee of CIIE.

**3. Deepen the application of science and technology, and create an intelligent supervision and service model**

Through the cross-border trade management big data platform and information technology, provides the whole-process supervision services for the exhibitors and exhibition products information of the CIIE, and creates a digital, intelligent, convenient and intensive supervision and service mode for the whole process of the CIIE.

**4. Send personnel to enter the site to provide service guarantee**

During the CIIE, Shanghai Customs will send personnel to the National Convention and Exhibition Center (Shanghai) to provide customs clearance, supervision, consultation and other services.

#### **5. The exhibition organizer shall provide unified tax guarantee to reduce the burden of overseas exhibitors**

For the temporary imported exhibits of the CIIE, the National Convention and Exhibition Center (Shanghai) Co., Ltd. shall provide the bank guarantee letter or customs duty guarantee insurance to the Shanghai Customs for the tax guarantee. Overseas exhibitors or their entrusted home transportation service providers shall hold *the Import Materials Certificate of the Fifth China International Import Expo 2022* and the *List of Import Materials of the Fifth China International Import Expo 2022*, thus to be exempted from submitting tax guarantee to the Customs order by order.

#### **6. Carry out nearby inspection to improve the level of exhibition facilitation**

The Shanghai Customs and relevant Customs shall complete the examination and approval procedures for the animal and plantation Origin as well as its products, food and herbal materials within 3 working days. According to the principle of "*convenient and operable*", exercise the right to accept and examine the imported aquatic products, dairy products and bird's nest sold in the exhibition area, and issue temporary registration approval (temporary registration approval is only used during the exhibition and in the exhibition area).

#### **7. Set up a special channel, give priority in handling procedures**

At major ports, set up VIP courtesy channels, special Windows for customs declaration and inspection of entry exhibits will be set up for the participating CIIE, and priority will be given to customs procedures such as declaration, inspection, sampling and testing, with immediate inspection and release.

## **8. Stabilize supervision measures and extending the temporary entry period of exhibits under ATA documents**

The supervision and service guarantee measures of previous CIIE will be fixed as format. And, the return period of temporary entry goods under the ATA document list is corresponding to the validity period of the document book.

## **9. Promote access negotiations and expand the types of imported exhibits**

Promote quarantine access negotiations with participating countries or regions, speed up the progress of risk assessment, support acceptable risk level agricultural and livestock products to participate in the exhibition and realize trade with China, and expand the types of imported exhibition products.

## **10. Simplify the supervision procedures to facilitate the entry of special articles**

Special articles (biological products) used for the prevention or treatment of diseases are allowed to enter the country with the prescriptions of doctors or relevant certificates from the hospital. The allowance is limited to a course of treatment determined by the prescription or instructions.

## **11. Simplify the entry procedures to facilitate the food and cosmetics exhibition**

Pre-packaged food and cosmetics only for the exhibition are exempted from adding Chinese label and sampling inspection, and the verification of the certificate; a small amount of trial and taste can be sampled before the exhibition with exemption from adding Chinese label; at the exhibition site for small amount of trial sale is exempted from adding Chinese label.

## **12. Simplify exit procedures and facilitate exhibition disposal after exhibition**

CIIE temporary imported exhibition (except the ATA documents under the temporary import for exhibition) after the CIIE, will be carried forward to the special customs supervision area and bonded supervision places (exhibition cars shall be transferred to the automobile bonded storage business of special customs supervision area and bonded supervision place), and approved for verification.

## **13. Support the normalization of bonded exhibition and sales, and expand the spillover effect of CIIE**

Enterprises registered in the customs special supervision area or in the bonded logistics center (type B) (hereinafter referred to as the "regional Center") may submit the bonded goods for guarantee and transport them to the bonded exhibition and sales place of the CIIE outside the regional center for exhibition and sales and other business activities.

## **14. Support cross-border e-commerce business and promote online and**

## **offline integration**

Imported exhibition items that are allowed to be included in the list of cross-border e-commerce retail imports (2022 edition) and enter the regional center after the end of the exhibition can be sold according to the mode of online bonded retail imports of cross-border e-commerce products.

## **15. Support cultural relics exhibits and go through the purchase procedures after the exhibition**

For the exhibits recognized as cultural relics by the State department of Cultural relics, it is allowed to participate in the form of temporary entry exhibits or bonded display; the State Department of cultural relics will allow the sale of cultural relics exhibits to be purchased by domestic consumers during the CIIE, in accordance with the provisions of the preferential tax policies for imported exhibits sold during the exhibition period of CIIE, the products can be imported duty-free accordingly.

## **16. Priority shall be given to testing and issuing relevant certificates for the qualified participating vehicles**

Exhibition vehicles need to complete single vehicle certification and China compulsory product certification (CCC) certificate, in accordance with *the law of the People's Republic of China on the prevention and control of air pollution* requirements to complete the six environmental protection information disclosure, customs will implement commodity inspection with priority and issue the *goods import certificate* and *import motor vehicles inspection Paper* and other relevant certificates.
