Conditions of participation :

Only bidders can participate in this call for tenders:

* Registered on the TUNEPS system and having the electronic signature certificate (www.tuneps.tn).

* Having the quality of Manufacturer or Reseller and justifying technical references and this by the supply in their offers of the parts required by the specifications.
