Invitation for 'Expressions of Interest' for 000085 – Provision of Integrated Pipeline Maintenance and Inspection Services

Brunei Shell Petroleum Co. Sdn Bhd (Company) is seeking Expressions of Interest (Eoi) from Contractors for the 000085 – Provision of Integrated Pipeline Maintenance and Inspection Services. Interested Contractors may elect to bid for one or all the Tender scopes as described below.

Tender Scope:

(1) Provision of Services for Progressive Cleaning, In-Line Inspection for Piggable and Unpiggable Pipelines

Objective of work is to carry out progressive cleaning, In-Line Inspection (ILI) to ensure integrity of pipeline is maintained. ILI tools used to survey pipeline onshore and offshore and assess failure risks such as corrosion, cracks, or any other anomalies.

Detailed scope of work is as below but not limited to:

1. Provision of Manpower, tools, equipment and facilities to carry out the works
2. Perform site visit or survey to Company's facilities to verify pipeline operational readiness and conditions
3. Execute pipeline cleaning and internal inspection for piggable pipeline
 - a. Pipeline cleaning (water driven)
 - b. Pipeline cleaning (nitrogen driven)
 - c. Pipeline cleaning (product driven)
 - d. Pipeline gauging (using mechanical device installed on cleaning pig or equivalent)
 - e. Provision of data logging tools
 - f. Provision of Geometry and Mapping tools
 - g. Full circumferential inspection of pipeline by means of wall loss detection tool
 - h. Any other services associated to cleaning, inspection and commissioning such as but not limited to fabrication and fitment of temporary piping, fittings, pig traps, supply of operation of pumping, flooding and drying spread including associated water treatment
4. Execute pipeline cleaning and internal inspection for nonpiggable pipeline
 - a. Pipeline cleaning (nitrogen/water driven)
 - b. Full circumferential inspection of pipeline by means of wall loss detection tool using a suitable technology
 - c. Any other services associated to cleaning, inspection and commissioning such as but not limited to fabrication and fitment of temporary piping, fittings, pig traps, supply of operation of pumping, flooding and drying spread including associated water treatment

(2) Provision of Pigging Services

Objective of work is to provide all services required to support routine cleaning pigging in all onshore/offshore pipelines.

Detailed scope of work is as below but not limited to:

1. Provision of Manpower, tools, equipment and facilities to carry out the works
2. Perform site visit or survey to Company's facilities to verify pipeline operational readiness and conditions
3. Pig Maintenance and Refurbishment, including body paint, part replacements and consumable
4. Pig Cleaning and decontamination
5. Procurement of pig parts or new cleaning pigs
6. Storage and preservation of spare parts in Contractor premises
7. Transportation and handling of pigs from/to Company from/to Contractor facilities
8. Management of Company Pigging fleet, including marking, tagging and inventory

Currently, Company has a fleet of 75 pigs from 4" to 40" in size from different manufactures at Onshore and Offshore Locations.

(3) Provision of Services for Pipeline Mechanical Cleaning

Objective of the work is to remove wax and scale inside the flowlines, pipelines and well tubing by performing solvent soaking and cleaning.

Detailed scope of work but not limited to:

1. Provision of Manpower, Tools and Equipment.
2. Site preparation and equipment set-up for cleaning activities
3. Company will isolate system and hand over the system for Contractor's connection.
4. Pre/post cleaning using borescope to verify cleanness pipe internal.
5. Cleaning and dewaxing of lines using mechanical cleaning in the forms of hydro-jetting, roto jetting or another suitable technology
6. Post cleaning flushing to remove loosened debris until water is running clear.
7. Hydrotest of carbon steel, duplex stainless steel and RTP Lines. RTP is non-metallic lines.
8. Collection of waste from pipe internal. Disposal by Company.
9. Separation of solid debris and oily wastewater.

Alternative Technology.

Contractors can submit a proposal of new method/technology which is different from the method as described above. Company is interested in new methods/technologies that provide lower cost, lower impact to production deferment and are effective in removing wax and scale. Please take note that, the water cut in some wells can be as high as 90% which can impact effectiveness of chemical/solvent. For new methods/technologies, company would request field trial to prove successful implementation based on 'No cure no pay' and Contractor will be paid upon successful trial. Terms and conditions to be agreed by both parties prior to field trial.

Technical Questionnaires:

For this EOI, interested Contractors are required to answer the questionnaires listed in Appendix A and submit them as part of the EOI submission. Failure to submit the questionnaires may result in disqualification for BSP EOI evaluation.
